Arizona Education Tax Credit Program

Arizona Revised Statute 43-1089.01



The **Arizona Tax Credit Program** (ARS 43-1089.01) allows individual Arizona taxpayers to receive a tax credit up to \$200 and married couples filing jointly up to \$400 for contributions in support of extracurricular activities or character education programs.

What does my donation pay for?

School tax credit donations help pay for extracurricular activities. Funds can apply to sports, arts and music programs, educational field trips, and most before and after school programs.

How much can I donate?

A person filing their tax return individually may contribute up to \$200. Married couples filing jointly may contribute up to \$400.

Who can donate?

Any Arizona taxpayer can make a tax credit donation, regardless of whether or not they have children in school.

Can I choose which extracurricular activities my money should benefit?

Yes, you can indicate areas of allocation, such as sports, art or music, educational field trips, or most before and afterschool programs.

When can I participate?

Right now! Schools are planning activities all year long. Your contribution can make a big difference in a young person's life.

Follow the 3 steps below:

1. Decide which school(s) in the Flagstaff Unified School District you would like to support. You may choose more than one school.
2. Complete the **Tax Credit Donation Form** and write a separate check to each school(s) of your choice.
3. Submit your donation in one of these ways:
 - **Mail** the form along with your check(s) to the District Office. **NOTE:** Donations must be postmarked by December 31.
 - **Drop off** the form and your check at the District Office (7:30 am – 4:30 pm Mon-Fri) or at the school of your choice before they close for Winter Break.

You will receive a receipt from Flagstaff Unified School District as proof of your donation. When you file your Arizona Income taxes in the spring, be sure to claim your tax credit. Contact your tax advisor for more information on how to do this.
